Dear Applicant:

Enclosed is an application for a Texas Reciprocal Cosmetology License. To be eligible for a Reciprocal Cosmetology License, you must submit the following:

- 1. Reciprocal License Fee of \$167.00**
- 2. Reciprocal Application, completed in full**
- 3. Copy of current license**
- 4. Letter of certification from state in which the current license was issued**

Note: You must contact the state in which your current license was issued and request that they send to you, or to the Texas Department of Licensing and Regulation, a letter of certification. To expedite the process, it is best for the other state to send you the certified letter, so that you may submit all of the paperwork to TDLR at the same time. However, you must be sure that the certified letter remains in the sealed envelope from the other state.

Always keep your mailing address current with the Texas Department of Licensing and Regulation. A license renewal notice will be mailed to your address of record prior to the date that your license will expire.

Note:

The Department will add your email address to the Cosmetology email notification list, which automatically provides information from the Department on matters affecting cosmetology. Your email address is confidential pursuant to the Texas Public Information Act and the Department will not share it with the public.
